Sub:- **Filling up of vacancy of two Members of GB by Election from the Heads of Training Institutions with reference to Section 3 (1) (b) (i) &(ii) of INC Act-procedure reg.**

As per section 3 (1) (b) (i) & (ii) of INC Act 1947, two members of GB are to be elected by the Principal of the Nursing Training institutions (B.Sc. & GNM) among themselves. The detailed procedure for conducting the said election as given in Section 34 Part IV of INC (Conduct of Business) Regulation 2009 is enclosed. Secretary INC is to conduct election as Returning Officer. INC has received 14 eligible nominations to contest the election. The ballot paper containing the names of the 14 contestants has been dispatched to all the voters i.e., Principals of the Nursing Training Institute (B.Sc. & GNM). The detailed instruction to cast the vote by the Principals of the institution and to return the ballot paper after voting in "secret" envelop has been dispatched to all the Principals of the Nursing Schools and Colleges. **It may please be noted that the vote is to be cast only by the Principals of the institution and not by other faculty members.** The ballot papers are to be returned in the return envelope furnished by INC after filling in the details and affixing the signature. The return envelope has to be sealed and sent to Secretary INC by speed post only. In case, the envelope is received without filling in the details and by any other mode other than speed post, it will be considered invalid.

The counting of votes will take place in the office of Secretary INC, on 16th May, 2017.

The schedule of election, list of eligible contestants and criteria for invalidation of ballot paper is enclosed.

1. Outer Envelope

- i. Received after the last date.
- ii. Received in any envelope other than the prescribed envelope supplied by the Returning Officer.
- iii. Received by ordinary post or by hand.
- iv. Name, address and signature of Head of Institution not duly filled up.

2. Inner Envelope

- i. If inner envelope is any envelope other than the supplied one
- ii. Not pasted
- iii. Any markings of Identification.

3. Ballot paper

- i. Any signature/ mark of identification on ballot paper.
- ii. If number of votes cast is more than two.
- iii. Any cutting or over writing.
