Guidelines to start various Nursing programme:

1. State Government while issuing NOC for GNM/B.Sc.(N), should ensure that institute, has own parent hospital of 100 beds. It will be appreciated if the Hospital name is mentioned in the Government Order (GO) and before issuing the Essentiality Certificate/Government Order/No Objection Certificate (NOC) assessment of existing nursing institution(s) in the districts may be done for feasibility of accommodating new institution. Scheduled tribal areas & HP, J&K, Uttaranchal and North eastern states are exempted from having own hospital.

2. As any Organization or Trust can open any number of institutions. **NOC should be issued** in the name of Nursing Institution along with the Trust name, and address of the nursing Institution. However, one Trust can open one institution in one city/town.

3. The name of the institution shall be unique i.e. the similar name institution should not be there in the state. Further, abbreviated name should not be accepted like Ramakrishna College of Nursing as RK College of Nursing by the same trust.

4. The distance between the location of two nursing courses should be more than 10 km's.

- Change of location (district/town/city/village) shall be considered under new proposal, and will not come under calendar of events or new guidelines, if the institution is permitted in the previous location.
- Last date will not be extended for 2016-17 academic year.

It is further reiterated that Government should not issue NOC for establishing nursing educational institution in the District/region where there are already number of nursing educational institutions exist. State Government may exercise Caution to issue NOC based on Calendar of Events, Guidelines for opening New Nursing Educational Institution of INC to only those district/region where there are No Nursing Educational Institution(s). Essentiality Certificate/Government Order (GO) issued after last date of submission to INC will be rejected.

Note: -

1. **New Proposal**

- Application for P.B.B.Sc.(N) will be considered only in case of recognized institutions conducting B.Sc.(N) course.
- 100 bedded parent/own hospital is essential to start GNM/B.Sc.(N) programme. However, condition of hospital is relaxed for scheduled notified hilly, tribal areas.

2. **Enhancement of Seats**

Institution is eligible to apply for enhancement of seats only if the previous/last inspection is conducted before 1st August, 2015. Government Order/Essentiality Certificate is required for Enhancement of seats also.
