**MEMORANDUM OF UNDERSTANDING**  
**BETWEEN**  
**NSDC INTERNATIONAL LIMITED**  
**AND**  
**INDIAN NURSING COUNCIL**

This Memorandum of Understanding ("MOU") made on the 8<sup>th</sup> day of June 2023 between NSDC International Limited ("NSDC INTERNATIONAL") and Indian Nursing Council ("SECOND PARTY") (hereinafter each referred to individually as a "Party" and collectively as "Parties).

WHEREAS NSDC International Limited, a public limited company registered under the Companies Act, 2013, is a wholly owned subsidiary of National Skill Development Corporation ("NSDC") and engaged in international collaborations including International Workforce Mobility for skilled and certified workers from India to other countries, International Advisory services among others. NSDC is a not-for-profit public limited company promoted by Government of India through Ministry of Skill Development and Entrepreneurship ("MSDE").

WHEREAS SECOND PARTY, The Indian Nursing Council is an Autonomous Body under the Government of India, Ministry of Health & Family Welfare being constituted by an act of Parliament, i.e The Indian Nursing Council Act 1947, in order to establish a uniform standard of training for nurses, Midwives and health visitors.

WHEREAS the Parties shall collaborate as per the terms and conditions mentioned hereunder.

This MOU does not constitute and is not intended to establish a legally binding agreement between the Parties. It solely reflects the intentions of the Parties, expressed in good faith but without creation of any legal obligation or the incurrence of any liability on the part of the Parties. The Parties agree that definitive agreements shall follow the execution of this MoU.

### Article Three

#### Confidentiality & Exchange of Information

1. The Parties shall protect and maintain the confidentiality of this MoU and any relevant materials, documents and information referenced herein.
2. Exchange of information and knowledge related to the purpose, scope and areas of cooperation under this MoU shall be made in a timely manner in order to ensure efficient and effective outcomes.
3. Notwithstanding the present article parties may disclose material, documents and information arising from the present MoU to the authorities/ministries governing their functioning or if required under any applicable laws.

### Article Four

#### Amendment and Dispute Resolution

This MoU may be amended at any time by the mutual written consent of the Parties. Any dispute or difference arising out of or in connection with the interpretation of this MOU shall be amicably resolved between the Parties. Detailed clauses pertaining to dispute resolution shall be provided under the definitive agreement.

### Article Five

#### Use of name/logos

The Parties may use the name, logo and/or official emblem etc. of the other Party pursuant to obtaining prior written approval by the other Party and such approval shall not be unreasonably withheld by the Parties.

### Article Six

#### Validity of this MoU

This MoU shall come in effect on 8<sup>th</sup> June 2023 and shall be valid for a period of 2 years unless terminated or upon the Parties entering into a valid definitive agreement. This MoU may be terminated by either Party upon giving one (01) month advance written notice to the other Party or by mutual written consent on a date mutually decided upon by the Parties.


